2.0 REQUIREMENTS

2.1 FORMAT

The format of the HMMP shall comply with Section 5 of National Aerospace Standard 411 (NAS411). Quantities shall be expressed with units (e.g., pounds/year (lb/yr)). The HMMP Plan shall describe the scope of the HMMP as prepared in accordance with (IAW) the applicable contract(s).

2.2 CONTENT

The plan shall address the following elements:

- a. HMMP objectives and content consistent with Section 4 of NAS411.
- b. When not specified in the contract, the plan will include proposals for the prohibited, restricted, and tracked Hazardous Material (HAZMAT) lists consistent with 1.4 of NAS411, using NAS411-1 as guidance.
- c. The approach for establishing priorities within the HMMP framework to reduce risk consistent with NAS411.

2.3 Reporting Hazardous Material

If it is determined by the subcontractor that hazardous material will be used under this PO/Subcontract Agreement, the subcontractor shall prepare, annually, a HMMPR in accordance with the requirements of DI-MISC-81397. Subcontractor format is acceptable.

2.4 REPORTING HAZARDOUS WASTE

If it is determined by the subcontractor that hazardous waste will be generated under this PO/Subcontract Agreement, the subcontractor shall prepare a Hazardous Waste Report in accordance with the requirements of DI-MGMT-82129.
